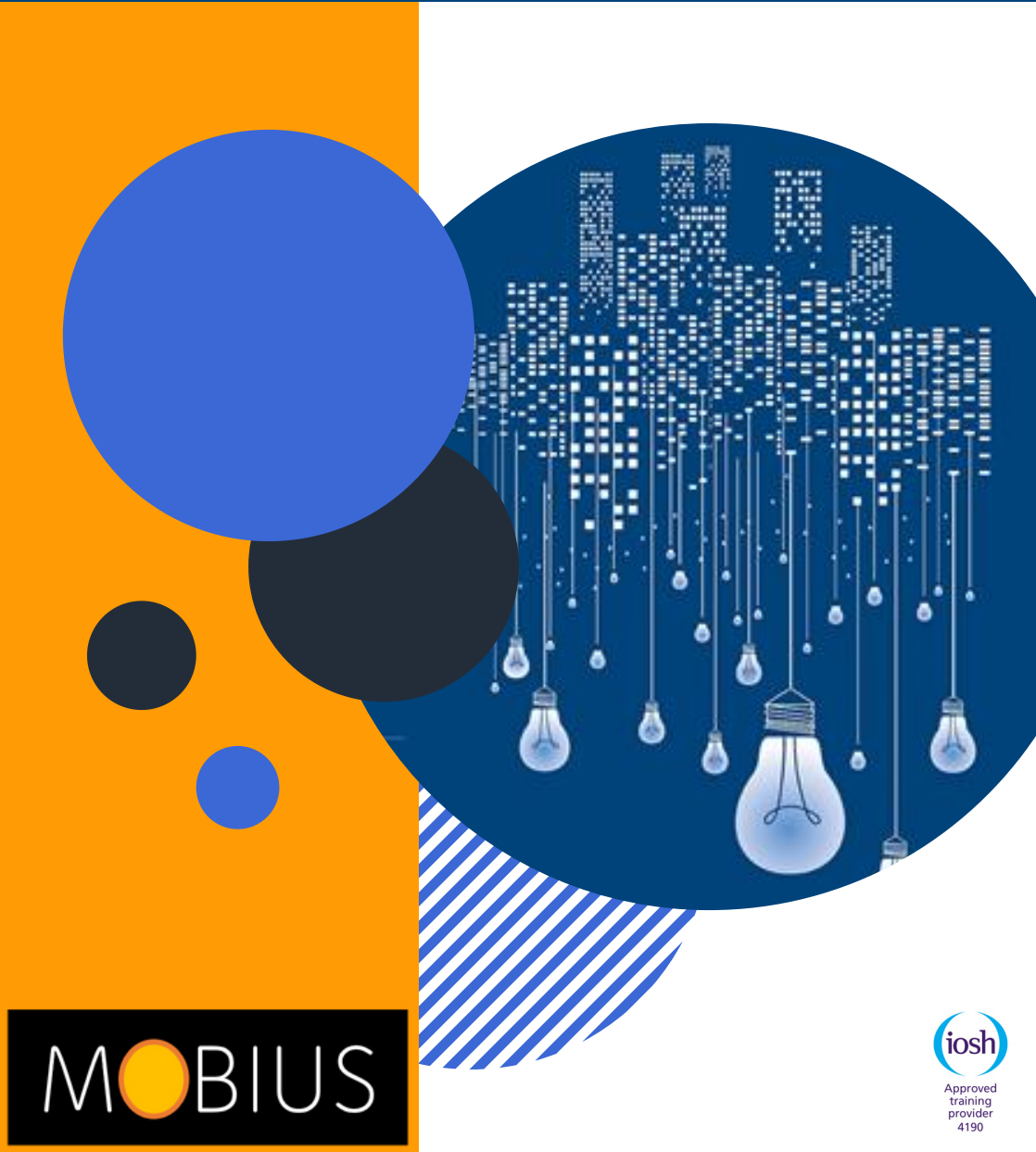

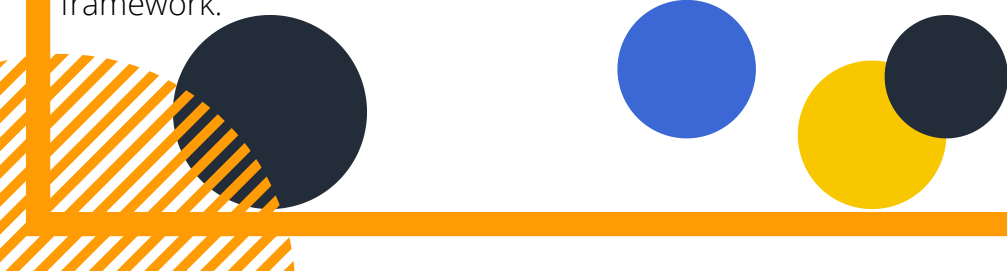

COURSE OVERVIEW

The NCFE IOSH Level 3 Certificate in Safety and Health for Business will give an understanding of how safety and health contributes to a business. It equips participants with the skills and knowledge they need to effectively influence change to safety and health culture within an organisation.

The qualification builds on Managing Safely to equip participants with the right knowledge and skills to:

- Evaluate safety systems
- Identify areas for improvement
- Implement control measures
- Reduce risk.

COURSE OBJECTIVES

The objective of this qualification is to enable participants to develop an understanding of safety and health in a business context.

What you will learn:

- How internal and external job roles affect safety and health in an organisation
- The main functions and aims of an organisation and how safety and health should be incorporated within them
- How to monitor safety and health performance and how improvement plans can be used to improve practices
- Understand organisational culture and techniques that can help develop a safety culture

- Tackling behavioural and operational challenges to boost business performance

Assessment

Complete a project researching organisational health and safety culture, using primary and secondary research methods to collect data.

Produce a report evaluating the existing safety culture and recommending an improvement plan.

Unit 3 A strategic, business focused approach to safety and health

- Ethics
- Compliance
- Managing uncertainty

Assessment

Analyse the main functions and aims of an organisation, including how strategic drivers affect its operation, then develop and deliver a video presentation to brief a senior management team.
